**Update**

The outcome of the restricted Meeting, March 5th, was briefly illustrated to the American Colleagues'. The unavailability of Prof Scalea for September Conference's fixed dates, due to a conflict with another important Meeting he must attend in the Hawaii, was announced too as the latest news. Concerns were expressed on running out of time without sorting out with actual invitations signed by the appropriate medical Authorities already agreed upon, as a consequence of endless discussions on signers.

## Discussions

Concerns were reported too on some frictions between two Italian Army Senior Flag Officers (Surgeon General and Army Medical Director) which could prevent LTG Marmo from signing invitations, as previously agreed. It was proposed to issue differentiated letter according to receivers to be signed respectively by BG Sebastiani (for Italian Military speakers), by Dr. Noschese and Prof Barbarisi, with BG Sebastiani representing the Organizing Committee (for Italian Civilian Medical Experts) and finally by LTG Borrini (for International Organizations/Allied Forces Nations) in case the conflict above mentioned still persists. It was proposed LTG Borrini should take care about mediating and resolving that conflict at his own level by means of direct talks with Senior Medical Flag Officers.

A fast approach to Civil Protection was urged as well as a rapid contact with Army Deployable Forces' Commander in Rome in order to get Role2 in Persano involved in the matter. BG Sebastiani to personally take care about two issues above mentioned. No further delay are allowed.

Potential support on building the structure of the web-site and about the scientific contents setting from SUN (second option) as an alternative to BLE Group's support (first option at 1500,00 € price) was explored. Dr. Vinciguerra to report to SUN WEB site responsible and provide Web Master's contact details to IT experts at DMML Caserta for a definitive answer on feasibility and sustainability of such a proposal.
